

Trip Agreement for IRELAND 2016

March 11-18, 2016

This TRIP AGREEMENT and \$300 deposit are due by May 1, 2015.

In order to participate on the IRELAND trip, I, _____, agree to the following:

- By the February 1, 2016 payment date, I will have a 2.0 GPA with no “Fs” in any of my classes.
- By the February 1, 2016 payment date, I will be in “good standing” (according to DHS Administration).
- I will have passed/checked off for any music being used for performance while in Ireland..
- **For color guard** – I will be an active member of the 2015-2016 Winterguard
- On the trip, **I UNDERSTAND and agree** to the following:
 1. Arrive on time to all events.
 2. Be in my assigned room **only**. No visitors – including family members. Chaperones will enter room (in pairs) for the sole purpose of checking rooms and following-up on reports of broken rules.
 3. Wear required clothing. (I.e., blue polo shirt; concert attire; parade uniform, etc.) DUSD/DHS dress code will be in effect and enforced.
 4. I must remain with the group. I am NEVER to be alone.
 5. FRONT DESK/MANAGEMENT OF HOTEL will be requested to turn off “extra” services (I.e., pay-per-view movies, video games, room service, etc.) Use of these “extra” services will be billed to student/group. I understand that I will be responsible for any bills that I and/or my roommates incur.
 6. All school & district policies/rules will be enforced. This trip is an extension of our District and city.
 7. Rules violated that are considered as “suspendable” will result in parent contact and school suspension. Mr. Everts will immediately contact administration. Once arriving in Dublin, CA., Mr. Everts will seek to enforce said ‘suspension’ and student possibly will be released from band/guard and receive a “W/ F” from band.
 8. Students & Chaperones are responsible for any items they bring and/or purchase on the trip.
 9. I am aware that luggage is weighed and will meet the weight requirement. If my luggage is overweight, I am responsible for those charges.
- **10. I am responsible for all school assignments/tests that I miss March 14-18, 2016.**

My parent/legal guardian understands and agrees to follow the payment schedule and refund policy:

- May 1, 2015 - \$300 (DEPOSIT – THIS IS A REFUNDABLE DEPOSIT – IF TRIP IS CANCELLED; Checks made payable to Irish Guard Music Boosters)
- September 1, 2015 - \$620
- October 1, 2015 - \$620
- November 1, 2015 - \$620
- January 4, 2016 - \$620
- February 1, 2016 - \$620
- Refund policy –The organizers of this trip will do all we can to seek a refund. **Items we may not be able to refund**: All transportation costs (chartered buses; airfare; etc.), hotel costs, etc. While we will do what we can to help retrieve monies, **a full refund may not happen.**
